- **Restart Secure Ride Service & Escorts**
 - Mass communication to Yale community on safety accessibility
 - LiveSafe app service, secure rides, escorts
 - Safety reminders, safety accessibility
- **Unsafe Pedestrian Crossing Conditions: York/ Frontage Road and York/MLK Jr. Blvd**
 - **Follow up:** City of New Haven: yellow road blockers (MLK Side), speed monitor, police surveillance
 - **Follow up:** Kristen Bechtel, City of New Haven (Erin Nozetz)
- **Status of Non-Yale Persons Accessing YSM Buildings and Need for Enhanced Security Presence**
 - Identify vulnerable areas (building access, parking) and deploy safety resources accordingly
 - Safety Considerations: key card access, video surveillance, front desk security, the challenge with tunnels, restricted visitor access, employee entrances, lighting.
 - Identify squatters in low traffic/low occupancy buildings
 - Non-Yale affiliated persons accessing YSM & Yale buildings
 - Unattended front desk and unsupervised employee entrance
 - Unauthorized YNNH Persons entering YSM
 - ID working group (in progress) - ID protocols throughout Yale
 - **Follow up:** Monitors building access of unauthorized persons (Nick Proto)
- **Progress of Assessment on Leased Properties**
 - Consistency in security standards across the network & Yale affiliated spaces
 - Create a language for safety and protocols for Yale affiliated leased buildings

- Maintain consistent safety standards across leased and owned properties
 - **Follow Up:** 300 George St. door & Long Wharf
 - 100 Church St. Handicap Accessibility & security standards (Sue Cascio)
- **Safety Communications**
 - Balance COVID issues with general safety concerns
 - Departmental presentations on the LiveSafe app, secure rides, escorts, etc.
 - **Follow-up:** Incorporate more signage on safety protocols and safety accessibility
 - Add QR codes to the campus blue lights (Duane Novello & Anthony Campbell)
 - **Follow-up:** Host departmental meetings on Covid safety measures while approaching normalcy.
 - Host during July 2M Meeting (Chris Digioia)
- **Reporting Incidents and Criminal Activity**
 - Enhance communication across all stakeholders, students, faculty, and staff and develop specific safety improvement recommendations
- **Additional Follow-ups**
 - Closing Cedar St. (during certain times) for Food Trucks, Yale Shuttles, and Pedestrians.
